beater for 1 minute on slow speed then 3-4 minutes at medium. If required, add 150g chocolate chunks, nuts or dried fruits and blend through. Fill muffin batter in muffin cups. Bake in a deck oven at 190-200°C or fan oven at 160-170°C for 30-35 minutes. These instructions are intended as a guide

and may require changes to fit certain baking conditions.
