220 g eggs. Frangipane cake: 1000 g Frangipane Mix, 300 g butter, 270 g water, 250 g egg. Have all starting materials at bakery temperature. Cream the butter. Mix Frangipane Mix, water egg. Add the butter and mix for 1 minute at low speed with a flat beater. For Frangipane Cake: mix for 1 minute at medium speed and 1 minute at low speed with a flat beater.
